

# A New Tack Shed for TROT

Most TROT supporters know that we accept donations of new and gently used tack and equine and equestrian gear. These donations are tax deductible and help both TROT and the equestrian communities in Tucson and the surrounding areas. Our program staff is the first to look through donations in search of items that can be used in TROT programs. The remaining equipment (and there is a lot of it) is offered in the fall and spring at two tack sales a year here on the TROT property. Because the prices are so reasonable, people come to the tack sale from all over the state, including Phoenix, Safford, and even Nogales. On average, the tack sales bring in over \$10,000 which goes directly to TROT programs!

This year, a TROT volunteer encouraged us to participate in a pilot program for plastic recycling in Tucson. She delivers TROT's plastic recycling to Ward 6 where Steve Kozachik, Ward 6 Council Member and Vice Mayor, is heading the project. The program collects all plastics and especially hard-to-recycle plastics that often end up in landfills because they cannot be recycled in your curbside blue recycling bin. ByFusion is a company that takes the recyclable plastics; shreds the materials; and through a



process of heat and compression, creates construction-grade blocks called ByBlocks. The blocks are 22 pounds of plastic which yields a 22-pound construction block. The product is all about creating a zero-waste stream.



Now let's get to the good part! TROT is going to be one of the first ByBlock construction sites in Tucson! We are replacing our 40-foot tack trailer with a spacious and purpose-built 20x40 foot building, expertly designed by Architect, Dave Shambach, and meticulously crafted by Kappcon Construction. This space is designed to provide accessible, organized, and community-friendly space for storage of high-quality, gently-used gear and equipment. With well-organized sections for saddles, bridles, riding appearl, all items can be easily accessed and inventoried.

This project is made possible by the financial assistance of the Deeney Sisters Fund which donated \$25,000 to start the project. Subsequently, Ward 6 Council Member and Vice Mayor, Steve Kozachik, Awarded TROT with \$100,000 from the City of Tucson.

This project is way past the first steps, but far from completion. It is now in the hands of the City of Tucson Permit department. We anticipate and look forward to the construction of the new tack storage building in the Summer of 2024! 

With the holiday season approaching, you will most likely see a number of Angel Trees around town. But did you know that TROT has a Holiday Giving Tree in all twelve feed stores in Tucson?

From December 1st through December 31st, you can find TROT's wishlist items clipped to decorated Christmas trees. These items are much needed supplies for our barn, property, and programs!

# **PROGRAM HIGHL**

SM has been riding at TROT since September. Her diagnosis of Primary Progressive MS affects her leg strength. When SM started at TROT in September, we did not know if she would be able to mount without using the wheelchair lift or if she would have the stamina to ride for a full half hour. In her first lesson, SM was able to make adjustments and mount with minimal assistance. Since then, she has been able to ride for the entire thirty minutes almost every time. SM has surprised us with her ability to learn and adapt very quickly. While riding Rune, she has developed the strength and coordination to use her reins and leg aids to ask Rune to walk forward, backwards, and to move laterally without assistance from her team. Riding Rune has given SM a sense of control and freedom of movement which she does not have in her day-to-day life.

TROT continues to be a leader in innovative equine-assisted activities by maintaining the distinguished title of Premier Accredited Center by PATH (Professional Association of Therapeutic Horsemanship International). This distinction is

highly respected, as only 15% of PATH's 850+ accredited centers globally have achieved this level of accreditation.

<u>What does Premier Accreditation really mean?</u> It means TROT is held to the highest standards. Every year, TROT reviews over 300 industry standards to Professional Association of Therapeutic Horsemanship International verify we are exceeding all criteria needed to maintain our status. These standards

include: safety, equine management, mental health training, adaptability and inclusion for those living with disabilities. The standards ensure that all programs are using current research and evidence-based models.

The entire operation (programs, property, and administration) undergoes a thorough audit every five years to ensure that all of the required standards are met. ALL of TROT's instructors are professionally trained and certified through PATH and



are required to complete a minimum of 25 continuing education hours annually on a variety of topics including but not limited to: disability and mental health education, equine welfare, and advanced horsemanship training. The list goes on about what it means to be a PATH Premier Accredited Center.

All of us at TROT are very proud of our status, and we are recognized nationally for our programs.

# Healing Happens Moment by Moment

Every Wednesday, connection is witnessed in the **Heroes & Horses** group. The morning begins with coffee brewing and welcoming smiles for our community's Heroes. For some, it is a visit to check out the program, and for others, it is a familiar mid-week sanctuary. It is a chance to gather while having a cup of coffee and a breakfast treat. The hum of conversation can be heard from the table outwards.

The transition to the barn occurs slowly. There may be stretching, some seated yoga, meditation, a walk in silence and gratitude for a new day--finding compassion for self and bringing that to the horses.

Each Hero is paired with an equine partner. Time is spent greeting their horse with the understanding that how they show up impacts the horse and vice versa. Each person learns how to halter, lead, and groom their horse, building relationship in the process.

It takes courage to show up and be vulnerable. Some of our activities include: a mindful walk with the horses to music; breathing exercises for awareness; herd meditation; connected grooming; imaginary lead line; Masterson Method; cowboy poetry, and a drumming circle. Connections grow, and relationships are built. Compassion for each other flourishes, and TROT continues to be a safe place for people to be their authentic selves.

*Heroes & Horses* is specifically designed to address the needs of veterans and first responders of all abilities in our community. Our vision is to help them achieve both physical and emotional goals and improve their quality of life through the power of the human horse connection.

To honor and pay special tribute to those who have served, TROT offers this program at no cost to the veteran or first responder.
